I refer to my below email, sent on Friday. I was just wanting to confirm that it reached you.

My client has also asked me to ensure that the Police are aware, that only days before the Bathurst (Raglan) Kingdom Hall was burned down, an article was published on the ABC news website and a Four Corners report was aired on the ABC, both of which contained inflammatory falsehoods about Jehovah's Witnesses, which in our view were capable of inciting hatred. The report and news article also featured footage of the Raglan Kingdom Hall as shown below.

Our client holds the property on trust for the Bathurst Congregation of Jehovah's Witnesses, which is an unincorporated association.

Our client is seeking any information or evidence that the Police have been able to uncover, or conclusions that they have drawn, which tend to establish whether or not the fire was started accidentally or intentionally, and if so by whom. Such evidence is critical to civil proceedings which our client wishes to commence as soon as possible.
